#### ROUND FOUR

**CREDIT MONEY & FINANCE** 

We are all used to shopping around for goods and services but many consumers do not take the same care in selecting the correct financial product for their circumstances. To make a good choice requires knowledge.

- What happens should a hire purchase company repossess protected goods without either a court order or the consumer's consent? All money paid is refundable
- If you buy a car on a three-year personal loan from a finance company arranged by the garage, when do you become the owner?
   Immediately on entering the agreement
- 3. Who is liable if a garage supplies you with a faulty car under a hire purchase agreement? **Hire purchase company**
- 4. Besides the consumer's signature, name one other piece of information that cannot be omitted from a consumer credit agreement? **APR**, **Ioan**, **repayment schedule**
- 5. A consumer can end all liability under a hire purchase agreement by paying half the hire purchase price and doing what else? **Returning the goods**
- 6. How many signatures are required to appear on a hire purchase agreement? **Two**
- **7.** Does a reduction in the lending rate generally cause house prices to rise or fall? **Rise**
- 8. In a bull market do the investors expect the shares to rise or fall in value? **Rise**

9. If a company is facing a takeover bid does its share price usually rise or fall? **Rise** 

#### ROUND FIVE HOME SHOPPING

If your home was once your castle it is now becoming your marketplace. There are special rules that apply to home shopping giving extra safeguards but consumers need to know them.

- You phone a double-glazing company and when their salesman comes to your home you agree to buy a new door at £1000 cash. Have you any rights to a cooling-off period? No. If you invite a sales person to your home there are no provisions regarding cooling –off rights.
- An uninvited salesman knocks the door and sells you a painting for £30. Have you any right to a cooling- off period? No. Whilst these circumstances would suggest a right to a cooling-off period the goods sold must be at least £35.
- **3.** An uninvited salesman visits your home and arranges to call back the next night when he sells you a carpet for £300. Have you any rights to a cooling-off period? **Yes. The first visit would have required a cooling-off period and that requirement extends to the second visit.**
- 4. When does the cooling of period for Internet sales start? With the delivery of the goods.
- 5. How long is the cooling-off period for an Internet sale? 7 days from delivery (or 7 days plus 3 months if no notice of rights has been given).
- 6. If you buy a sealed DVD on the Internet what happens to your coolingoff rights when you break the seal? **That ends your cooling-off period**
- 7. QVC is a sales channel on television. What does QVC stand for? Quality, value and convenience
- 8. What organisation based in Dublin arranges secure payments for eBay transactions? **Paypal**

9. What is feedback on eBay? Comments made by a Trader's customers, available for inspection and useful for intending purchasers

TRAVEL, TOURISM & TRANSPORT

- **3.** A package holiday must contain two out of three elements. Can you name any two? **Transport, Accommodation Or Other Tourist Services**
- 4. What is the cooling-off period for a timeshare sold in France? **10 days** because the sale is regulated by European Regulations
- 5. How much of an advance deposit may a timeshare seller demand prior to the cooling-off period? **No deposit**
- 6. What is the cooling-off period for a timeshare sold in the Fermanagh Lakeland's? 14 days because this sale is regulated by UK law & the regulations provide a longer period
- 7. Hopefully you will not need form e111 but what does it do? Gets you free health treatment in European Union
- 8. To visit the USA your passport must be valid for how long from the date of your proposed visit? **Six months at least**
- How many customs channels are there at an international airport in the United Kingdom? 3 – Red, Blue & Green
